### **GENERAL RULES:**

- No refunds on slips
- No subleasing of slips.
- Pets are welcome but must be under supervision at all times.
- Each lessee is responsible for own litter.
- Only all-weather doormats on piers — no carpeting on piers and tie poles.
- Keep bath houses locked at all times
- No live aboards, RVs, trailers, or motor homes.
- Follow posted swimming pool rules.

**LIABILITY:** (a) This lease is for rental of a boat slip only, such slip to be used at the sole risk of the Boat Owner, and Stingray Point Marina shall not be liable or responsible for the care and protection of the boat (including gear, equipment and contents) nor for any loss of damage of whatever kind or nature to the boat, its contents, gear or equipment, howsoever occasioned.

(b) Boat Owner shall indemnify and hold harmless Stingray Point Marina from and against any and all claims, damages and liabilities arising out to the possession, use or non-use of the boat or boat slip including without limitation, any negligence or improper conduct of Boat Owner or his or her agents, employees, invitees, suppliers, or licensees, and all cost including attorney's fees, incurred by Stingray Point Marina incident thereto.
